1. Establishment and Legislative Recognition:

Mahatma Gandhi University, Sikkim ("the University") has been lawfully established by the **State Government of Sikkim** pursuant to the authority conferred under Sikkim Act No. 21 of 2022, duly notified in the Official Gazette of Sikkim **dated 16th September 2022**. All statutory details and documents were submitted by authorized university officials as per regulatory directives on **07 March 2023 to the UGC**.

2. Statutory Amendments and UGC Correspondence:

In furtherance of statutory requirements and ongoing regulatory oversight, the University Grants Commission (UGC), by communication dated 13 July 2023, addressed the Higher Education Department of Sikkim as regards proposed amendments to the original Act. Pursuant thereto, the Mahatma Gandhi University Sikkim (Amendment) Act, 2025 (Act No. 09 of 2025) was duly enacted and published in the Sikkim Gazette on 30th April 2025.

3. Compliance with UGC Directives:

The University received an official communication from the **UGC dated 30 July 2025** requiring the submission of an attested copy of the **Mahatma Gandhi University Sikkim (Amendment) Act, 2025** and an update of contact details for the Vice-Chancellor and Registrar. **All required documents and particulars were duly submitted to the UGC by MGU Sikkim on 31 July 2025.**



4. Status of UGC Recognition, Disclosure, and Public Self-Disclosure::

The process of formal **inclusion of Mahatma Gandhi University, Sikkim's name in the UGC's official lists is currently under process.** In accordance with the UGC's Public Self-Disclosure Mandate, all relevant correspondence, compliance documents, statutory notifications, and communications with the UGC and State Authorities are made available for inspection and public reference on the University's official website: **www.mgusikkim.com.** **This fulfills the requirement under UGC guidelines for transparency and public self-disclosure by higher education institutions.**
